GDPR and WZO Privacy Policy

General Data Protection Regulation (GDPR)

The main intent of the GDPR is to give individuals more control over their personal data, impose stricter rules to companies handling it and make sure companies embrace new technology to process the influx of data produced. This new directive has clearly been created acknowledging that people produce much more sensitive data than they have ever before. Managing data on a large scale can be risky for organisations if they do not plan out an appropriate strategy and update their systems to handle the influx.

Information Requests under GDPR

You have a right to know what we know about you, make changes or ask us to stop using your data

You have a right to ask us to stop processing your personal data, and if it's not necessary for the purpose you provided it, we will do so. Please contact us at any time if you have any concerns.

You have a right to ask for a copy of the information we hold about you. If you believe that any information we are holding on you is incorrect or incomplete, please contact us as soon as possible. We will promptly correct any information found to be incorrect.

WZO Privacy Policy

WZO understands and respects the importance of your privacy and we are committed to safeguarding your personal information. In providing our service to our paid members, we have obtained personal information from you and this policy outlines how we treat your personal data after it has been entered in our secured Database.

The information we hold of our Members, Donors and Friends of WZO

Names and Contact Address details

Telephone number, Date of Birth and Email Address

Children's Data

We only hold children's data for families who have enrolled for Family Membership which is provided by the primary family member. After the age of 18 the child ceases to be a family member unless he/she remains in higher education till the age of 25.

You are responsible for ensuring that other members of your family are aware of the content of this Policy and consent to your acting on their behalf in all your dealings with us.

Please note we do not collect or obtain members information from websites, social media or any other list or directories apart, apart from data supplied to us on a membership form by yourself.

What we do with Information on our Members and Donors Database

For internal record keeping (ie reminder for membership renewals, record updates)

We will also use your details to send you notifications and communicate with you generally and of our primary charitable activities and work. (ie Donation Acknowledgement, Receipts, Gift Aid forms, Appeals, Events, AGM, etc)

We will only contact you using the details you provide for reasons directly relating to our charitable and community activities

We may need to disclose your information where required by law, where such a request is made by a legal authority. We will investigate any Data Breaches reported to us.

Please note that we do not share, disclose or sell your personal information to third parties

Updates

You may notify us of any updates, amendments and corrections to previously submitted Information.

In accordance with the Data Protection Act 1998, you may ask us in writing for a copy of the information we hold about you and to correct any inaccuracies in your information. We aim to respond to you within 21 days from the date of request.



Emails and Mailers:

The content of the emails that WZO sends is confidential and intended for the recipient specified in the email/ document/message only. It is strictly forbidden to share any part of email/document/message with any third party, without the written consent of WZO. If you received any email/ document/message sent by WZO by mistake, please reply to the email/ document/message and follow with its deletion, so that we can ensure such a mistake does not occur in the future.

The email/document/message that WZO sends is part of discussion between The World Zoroastrian Organisation and the addressee whose name is specified in the email/ document/message. Should you receive any email/ document/message by mistake, we would be most grateful if you informed us that the email/ document/message has been sent to you.
